Unlike typical commercial benefit plans, ACA orthodontic benefits require pediatric orthodontics to be "medically necessary." Patients with medically necessary orthodontic cases usually present with moderate to severe malocclusion, severe crowding, open bites and/or significant x-bites. This is a part-time independent contractor position (3-5 hours/week).

CareFirst Dental Advisory Committee or CareFirst Credentialing Committee CareFirst is seeking an in-network licensed dentist to participate as a member of our Credentialing or Dental Advisory Committees. #### Federal Employee Program Accidental Injury Benefit – What You Need to Know

You may not know that patients who are members of the Blue Cross Blue Shield Federal Service Benefit Plan (commonly referred to as the Federal Employee Plan, or FEP) have access to benefits for dental care necessary to as a result of and directly related to an accidental injury.

This accidental injury benefit requires documentation of the condition of the teeth before the accidental injury, documentation of the injury from the provider, and a treatment plan for your patient's dental care. CareFirst (or your local Blues plan) may also request updated treatment plans as your patient's treatment plan progresses.

An accidental injury refers to an injury caused by an external force or element such as a blow or fall and that requires immediate attention. Injuries to the teeth while eating are not considered accidental. Based on the nature of the injury, the benefit may be considered under the medical plan, or the dental plan.



## What to do when your patient has dual coverage for pediatric orthodontics

Affordable Care Act (ACA) products include coverage for pediatric orthodontic services, and are only available if a pre-treatment estimate (PTE) is submitted and the case meets the medical necessity criteria (as defined by each jurisdiction's orthodontic necessity form).

However, some patients may have dual coverage with CareFirst, and this may cause some confusion. Below, you will find a breakdown of what you can expect when submitting claims for these cases.
