
The front of the member ID card contains information about the member, the primary care provider (PCP), copayments/coinsurance and some member benefits

- 2 Member ID and Group number
- 3 Dental coverage
- 4 Plan name, PCP name (if applicable)
- 5 Plan Type Indicator

DP—Dental Preferred (PPO), GRID & GRID+
DT—Dental Traditional, GRID+
PD—Pediatric Dental
DH—DHMO
DS—Individual Select Preferred
DE—Dental EPO (PPO, Traditional)

The back of the member ID card includes contact information for members, as well as instructions and an address for filing claims and sending correspondence.

The program offers providers access to more patients who hold the Cross and Shield insurance. Participating providers submit claims directly to the member's plan. Providers will also be paid by the member's plan, according to the provider's current CareFirst reimbursement agreement.
