CareFirst values the care our members receive at your practice. Thank you. Based on our member rosters, your practice is eligible to participate in an expanded quality incentive program for Medicare Advantage and Medicaid members in your practice in 2025. This letter describes the incentive program structure and how to participate this year.

CareFirst 2025 Medicaid and Medicare Advantage Incentive Program

The 2025 incentive program offers a tiered reward system for practices that meet quality goals for Medicaid and Medicare Advantage members. Performance in this program will be calculated based on claims, administrative data, and supplemental data reflecting care provided between January 1 and December 31, 2025. CareFirst will provide progress reports through the year and will calculate final award amounts in Q2 2026 to accommodate claims submissions.

The measures are listed in Tables 1 and 2 below.

Clinical process measures can earn the following:

- \$50 total per member for 5-star performance, or
- \$35 per member for 4-star performance, or
- \$10 per member for average performance (National HEDIS mean for Medicaid, 3-star rate for Medicare Advantage).

Clinical outcome measures follow the same tiered structure and earn more at each performance level:

- \$75 total per member for 5-star performance, or
- \$52.50 per member for 4-star performance, or
- \$15 per member for average performance.
